In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income from salary is Rs.47,35,157/- and total deductions/savings/investment against GIS, GPF, PPF, Insurances and Income Tax is Rs.20,50,151/- and the balance of his savings bank account(s) is also increased by Rs.11,17,817/- in this financial year from previous year's balance, total of which is Rs.31,67,968/-. Thus, a sum of Rs.15,67,189/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2020-2022 (2020-21 & 2021-22).

It is pertinent to mention here that his wife is a Judicial Officer, having annual income of Rs.22,34,932/& Rs.27,55,977/- in the financial year 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id: P00005202020 (Old Case Id: 1259) and the same has been seen by Hon'ble Mr. Justice Jayant Banerji, the then Administrative Judge, Saharanpur Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 18.06.2022. As such, there is no delay in submitting the same.
