May kindly see the property statement online received from Sri Anurag Panwar, Special Judge(SC/St Pev.of Atroci Act), Hathras regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019 - 2021 (2019-2020 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019 - 2021 (2019-2020 & 2020-21) of the officer concerned, details of income, deduction, savings, investment and expenditure made by him are given below:

(1) In the financial years 2019 - 2021 (2019-2020 & 2020-21), his total income is Rs.29,44,362/- (Income from salary and arrears) and total deduction/ repayment/ savings/ investment/ against G.I.S., Income Tax, P.P.F. and the balance of his savings bank accounts is enhanced for Rs.10,93,622/- this financial year from previous year's balance are Rs. 18,51,922/-. Thus, a sum of Rs.10,92,440/- was available with him to meet out the household expenditure of his family consisting four members for the financial year 2019 - 2021 (2019-2020 & 2020-21).

It is pertinent to mention here that his wife Smt. Jyotsna Siwach Wife of the officer is an Advocate whose income 2.5 Lakh Per Annum.

In this connection, it is further submitted that officer has already submitted his property statement at the time of joining the U.P. H.J.S which has already been seen by Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Hathras in case id no.854.

It is again submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2019-2021 (2019-2020 & 2020-21) in its next financial year i.e. 2021-22 upto March, 2022. He has submitted the aforesaid movable and immovable property statements vide online letter dated 29.06.2022. As such, there is delay in submitting the aforesaid property statements from the part of officer for which officer has stated that he had joined the service on 21/08/2019. He has submitted his property statement at the time of joining in March 2020. He was under a bona-fide impression that now he has to submit his property statement for the financial year 2020-2021 and 2021-2022 in the year 2023. However, subsequently he came to know that he had to submit the property statement for the financial year 2020-2021 and 2021-2022 in the year 2022 itself. The prevailing Covid circumstances since last 2 years and frequent closure of courts resulted in an innocuous mistake in determination of due date for deposition of property statement. The delay is totally unintentional and bona-fide. The delay in submission of property statement may kindly be condonoed and the property statement may kindly be taken on record.

May, therefore, if approved, property statements for the financial years 2019 - 2021 (2019-2020 & 2020-21) of Sri Anurag Panwar, Special Judge(SC/St Pev.of Atroci Act), Hathras be laid before Hon'ble Mr. Justice Narendra Kumar Johari, Administrative Judge, Hathras for His Lordship's kind perusal and orders?
