In this connection, it is submitted that the officer has already submitted his property statements online upto the financial year 2018-20 which had already been processed online on case id no.P00062352022 before Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Hathras .

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial years 2020 - 2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements for the financial years 2020 - 2022 (2020-21 & 2021-22) f vide his online application dated 06.09.2022. As such, there is no delay in submitting the same from the part of the officer.
