May kindly see the property statement submitted online dated 27.06.2022 received from Sri Mohammad Azad, Additional District & Sessions Judge (F.T.C.), Jalaun at Orai, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-22 (2020-21 & 2021-22), gross salary is Rs.41,44,096/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, LIC and the balance of his savings bank account(s) is also enhanced for Rs.29,687/- this financial year from previous year's balance, total of which is Rs.11,24,034/-. Thus, a sum of Rs.30,20,062/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

It is pertinent to mention here that his wife's (Farmina Khatoon) annual income is Rs.5 lacs approx (as an advocate).

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2018-20 which has already been processed online before Hon'ble Mr. Justice Dinesh Pathak, Administrative Judge, Jalaun at Orai on old case ID no.2848.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-22 (2020-21 & 2021-22) vide online dated 27.06.2022. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial years 2020-22 (2020-21 & 2021-22) of Sri Mohammad Azad, Additional District & Sessions Judge (F.T.C.), Jalaun at Orai be laid before Hon'ble Mr. Justice Dinesh Pathak, Administrative Judge, Jalaun at Orai Judgeship for His Lordship's kind perusal and orders?
