May kindly see the property statement online received from Sri Sushil Kumar-V, Civil Judge (Senior Div.), Gautambuddha Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2017-19 (2017-18 & 2018-19), Total income from Salary and other sources is Rs.31,82,668/- (Gross Salary Rs.30,17,988/- and Rs.1,64,680/- from agriculture income) and total deductions/savings/ investment against NPS, GIS, PPF, Income Tax, Insurances, Mutual fund, Sukanya Samridhi Yojna, 'U/s ch VI A' and the balance of his savings bank account(s) is also enhanced by Rs.9,52,610/- in this financial year from previous year's balance, total of which is Rs.23,94,766/-. Thus, a sum of Rs.7,87,902/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the both of the financial year.

In this connection, it is submitted that the Officer has already submitted his property statement up to the financial year 2016-17 offline(Misc. File of the Officer ) and same has been processed before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Gautambuddha Nagar for His Lordship's kind perusal and orders

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial year 2017-19 (2017-18 & 2018-19) vide online dated 26.06.2022. As such, there is delay in submitting the same. In this regard, officer stated that delay is caused due to pandemic.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Sushil Kumar-V, Civil Judge (Senior Div.), Gautambuddha Nagar be laid before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Gautambuddha Nagar for His Lordship's kind perusal and orders?
