(1) In the financial years 2019-21 (2019-20 & 2020-21), Total income from Salary and other sources is Rs.32,40,204/- (Rs.28,85,273/- from salary and Rs.3,54,931/- from agriculture)- and total deductions/savings/ investment against NPS, GIS, PPF, Income Tax, Repayment of Home loan, Mutual Funds, Sukanya Samridhi Yojna and Insurance is Rs.19,14,142/-. Thus a sum of Rs.13,26,062/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2019-21 (2019-20 & 2020-21) and the balance of his savings account is also decreased for Rs.13,24,627/- this financial year from previous year balance.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2017-19 (2017-18 & 2018-19) online against case id- P00062382022 and same has been processed before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Gautambuddha Nagar for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial year 2019-21 (2019-20 & 2020-21) vide online dated 26.06.2022. As such, there is delay in submitting the same. In this regard, officer stated that delay is caused due to pandemic
