May kindly see the property statement online received from Sri Mritunjay Srivastava, District Legal Services Authority, Shravasti regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2017-2019 (2017-2018 & 2018-2019) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-2019 (2017-2018 & 2018-2019) of the officer concerned, details of income, deduction, savings, investment and expenditure made by him are given below:

(1) In the financial years 2017-2019, total income is Rs. 27,14,169/- (Gross salary is Rs. 23,03,886/- and from maturity of F.D. is Rs. 4,10,283/-) and total deduction/ repayment/ savings/ investment/ against N.P.S., L.I.C., G.I.S., P.P.F., N.S.C., Income Tax, repayment of Car Loan, F.D., booking of flat and the balance of his saving bank account is enhanced for Rs. 1,19,680/- this financial year from previous year's balance, total of which is Rs. 20,97,828/-. Thus, a sum of Rs. 6,16,341/- was available with him to meet out the household expenditure of his family consisting three members for the financial year from 2015-2017.

It is pertinent to mention here that his wife, Tulika Srivastava is a scale-II manager in Punjab National Bank having income of Rs. 8,00,000/-(approx).

In this connection, it is further submitted that officer has already submitted his property statement for the period of 2015-2017 which had already been seen by Hon'ble Mr. Justice Abhinava Upadhyaya, the then Administrative Judge, Bareilly on the miscellaneous file of the officer with the remark "In future promptness must be shown in declaration".

It is again submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2017-2019 (2017-2018 & 2018-2019) in its next financial year i.e. 2019-2020 upto March, 2020. He has submitted movable and immovable property statements of the financial years 2017-2019 (2017-2018 & 2018-2019) vide online letter dated 08.01.2021. As such, there is delay in submitting the same, for which officer has not given the reason of delay.

May, therefore, if approved, property statements for the financial years 2017-2019 (2017-2018 & 2018-2019) of Sri Mritunjay Srivastava, District Legal Services Authority, Shravasti be laid before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Shravasti for His Lordship's kind perusal and orders?
