In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income from salary and other sources is Rs.41,06,251/- and total deductions/savings/investment against GIS, NPS, PPF, Sukanya Samriddhi Account, Mutual Funds, loan repayments including amount paid other than loan and Income Tax is Rs.18,54,509/- and the balance of his savings bank account(s) is also increased by Rs.9,24,724/- in this financial year from previous year's balance, total of which is Rs.27,79,233/-. Thus, a sum of Rs.13,27,018/- was therefore available with him to meet out the household expenditure of his family consisting five members of the financial year 2020-2022 (2020-21 & 2021-22)

Judicial Service online against Case Id: P00010012021 (Old Case Id: 3088) and the same has been seen by Hon'ble Mr. Justice Piyush Agrawal, the then Administrative Judge, Basti Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 01.07.2022. As such, there is no delay in submitting the same.
