May kindly see the property statement received online from Smt. Arti Fauzdar, Addl. District & Sessions Judge, Chandausi-Sambhal at Chandausi, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

**In the financial year 2020-2022 (2020-21 & 2021-22)**, the Gross income is Rs.47,78,242/- ( Rs.46,77,211/- from Salary & Rs.1,01,031/- from Interest) and total deductions/ repayment/ savings/ investment against GIS, NPS, PPF, loan repayments and Income Tax are Rs.32,57,093/-. Thus, a sum of Rs.15,21,149/- was therefore available with her to meet out the household expenditure of her family consisting four members in the both financial year and the balance of her savings bank account is also decreased by Rs.18,74,567/- in this financial year from previous year's balance.

It is pertinent to mention here that her husband, retired from Delhi Judicial Service, have gross income of Rs.20,00,000/- approx. from pension and other sources during both financial years, as mentioned by the officer.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20), online against Case Id : P00007802021 (Old Case Id : 2849) and the same has been seen by Hon'ble Mr. Justice Deepak Verma, the then Administrative Judge, Ambedkar Nagar Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 03.07.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Smt. Arti Fauzdar, Addl. District & Sessions Judge, Chandausi-Sambhal at Chandausi, be laid before Hon'ble Mr. Justice Vinod Diwakar, Administrative Judge, Sambhal Judgeship for His Lordship's kind perusal and orders?
