May kindly see the property statement online received from Sri Rajesh Chaudhary, Special Judge (E.C. Act), Kanpur Nagar, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), Gross income is Rs.51,50,397/- (income from salary including arrears is Rs. 48,26,683/- and income from allowances is Rs. 3,23,714/-) and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, PPF, repayment of housing loan, Insurances and the balance of his savings bank account(s) is enhanced by Rs.9,44,327/- this financial year from previous year's balance, total of which is Rs.45,46,432/-. Thus, a sum of Rs.6,03,965/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2018-20 online against case id no-3213 and same has been moved before the Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-22 (2020-21 & 2021-22) vide online dated 26.07.2022. As such, there is delay in submitting the same. For which, he has not given any reason.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Rajesh Chaudhary, Special Judge (E.C. Act), Kanpur Nagar be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar for His Lordship's kind perusal and orders?
