In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2020-22 (2020-21 & 2021-22), her gross income from salary is Rs.43,41,815/- and total deductions/Savings/investments against Deposits in saving bank account, GPF, GIS, Income Tax, Repayment of home loan, PPF and Insurance are Rs.26,16,047/-. The balance of Rs.2,26,517/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.17,25,768/- was therefore available with her to meet out the household expenditure of her family consisting four members in the financial years 2020-22 (2020-21 & 2021-22).

It is pertinent mention here that's Officer's Husband (Advocate) having annual income was Rs.6,50,000/- for the financial year 2020-21 & Rs.7,00,000/- for the financial year 2021-22 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2018-20 (2018-19 & 2019-20) online against case id- P00001592021 (Old Case Id :2137), which has already been seen by Hon'ble Mr. Justice Neeraj Tiwari, the then Administrative Judge, Jhansi Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 18.07.2022 on eServicesJo portal. As such, there is no delay.
