May kindly see the property statements online received from Sri Bans Bahadur Yadav, presently posted as Presiding Officer, Commercial Court, Kanpur Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22(2020-21 & 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-22(2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-22(2020-21 & 2021-22), Total income from salary and other sources is Rs.48,14,343/- (Rs.48,01,642/- is gross Salary for both the financial years & Rs.12,701/- Maturity amount of LIC Policy no. 213258669) and total deductions/repayment/ savings/ investment against GPF, GIS, GVR Income Tax, loan, PPF and LIC policies are Rs.28,62.604/-. Thus, a sum of Rs.19,51,739/- was therefore available with him to meet out the household expenditure of his family consisting six members for both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.30,000/- this financial year from previous year's balance.

In this connection, it is submitted that officer has already submitted his property statement for the financial year 2018-20 which has been processed before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgship for His Lordship's kind perusal and orders on the case id no. P00007742020 (Old Case Id : 1618).

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22(2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-22(2020-21 & 2021-22) vide online dated 05.08.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2020-22 (2020-21 & 2021-22) of Sri Bans Bahadur Yadav, presently posted as Presiding Officer, Commercial Court, Kanpur Nagar, be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgship for His Lordship's kind perusal and orders?
