It is pertinent to mention here that his wife is posted as Additional District Judge, Hapur having monthly income of Rs.2,00,000/-.

In this connection, it is submitted that officer has already submitted his property statement upto the financial year 2018-20 online against case id- P00004932020 and same has been moved before Hon'ble Mrs. Justice Saroj Yadav, Administrative Judge, Hapur.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22(2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-22(2020-21 & 2021-22) vide online dated 21.07.2022. As such, there is no delay in submitting the same from the part of the officer.
