May kindly see the property statement online received from Sri Umakant Jindal, Spl. Judge. (SC/ST, Pev.of Atroci Act), Hapur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22(2020-21 & 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-22(2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-22(2020-21 & 2021-22), Gross income from salary is Rs.39,79,754/- and total deductions/ repayment/ savings/ investment against CPF,GIS, PPF, Sukanya Samridhi Yojna, Income Tax, LIC policy's, ICICI policy's, Home loan EMI and the balance of his savings bank account(s) is enhanced by Rs.3,54,079/- this financial year from previous year's balance, total of which is Rs.34,20,454/-. Thus, a sum of Rs.5,59,300/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

It is pertinent to mention here that his wife is posted as Additional District Judge, Hapur having monthly income of Rs.2,00,000/-.

In this connection, it is submitted that officer has already submitted his property statement upto the financial year 2018-20 online against case id- P00004932020 and same has been moved before Hon'ble Mrs. Justice Saroj Yadav, Administrative Judge, Hapur.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22(2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-22(2020-21 & 2021-22) vide online dated 21.07.2022. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2020-22(2020-21 & 2021-22) of Sri UmaKant Jindal, Spl. Judge. (SC/ST, Pev.of Atroci Act), Hapur be laid before Hon'ble Mrs. Justice Saroj Yadav, Administrative Judge, Hapur Judgeship for Her Lordship's kind perusal and orders?
