May kindly see the property statement online received from Dr.(SMT) Reema Bansal, Additional District & Sessions Judge, Hapur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2020-22(2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22(2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2020-22(2020-21 & 2021-22), Gross income from salary is Rs.42,83,749/- and total deductions/ repayment/ savings/ investment against GIS, PPF, Sukanya Samridhi Yojna, LIP, Income Tax, CPF, ICICI Protest Policy, ICICI Prudential Insurance Policy, Car Loan EMI is Rs.24,19,449/-. Thus, a sum of Rs.18,64,300/- was available with her to meet out the household expenditure of her family consisting of four members in both of the financial years and the balance of her savings bank account(s) is decreased by Rs.24,106/- this financial year from previous year's balance.

It is pertinent to mention here that her husband is posted as ADJ, Hapur having montly income Rs.1,75,000/- approx.

In this connection, it is submitted that the Officer has already submitted her property statements of the 2018-20 online against case id- P00004812020 and same has been moved before Hon'ble Mrs. Justice Saroj Yadav, Administrative Judge, Hapur Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2020-22(2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements of the financial years 2020-22(2020-21 & 2021-22)vide online dated 21.07.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22(2020-21 & 2021-22) of Dr.(SMT) Reema Bansal, Additional District & Sessions Judge, Hapur be laid before Hon'ble Mrs. Justice Saroj Yadav, Administrative Judge, Hapur for Her Lordship's kind perusal and orders?
