May kindly see the property statement received online from Sushri Annu, Additional Civil Judge (Junior Div.), Nagina-Bijnor regarding submission of statement of movable and immovable properties acquired/held by her, for the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2019-21 (2019-20 & 2020-21), Gross income from salary is Rs.16,16,336/- and total of deductions/savings/investment against GIS, NPS, Income Tax, PPF & car loan is Rs.4,48,990/-. Thus, a sum of Rs.11,67,346/- was therefore available with her to meet out the household expenditure for herself in both of the financial years. And the balance of her saving bank account is also reduced by Rs.13,924/- in this financial year from previous year's balance.

In this connection, it is submitted that the Officer has submitted her property statement held at the time of joining into U.P. Judicial Service and the same has been seen online against Case Id : P00006102020 by Hon'ble Mr. Justice Vipin Chandra Dixit, the then Administrative Judge, Kasganj Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted her movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide online dated 15.09.2022. As such, there is delay in submitting the same from the part of officer, for which she has stated that 'the applicant is newly appointed in judicial service in 2019 and due to training period and after that covid situation applicant failed to furnish the above information on time and further requested to kindly condone the delay as the applicant assures not to repeat this in future.'

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sushri Annu, Additional Civil Judge (Junior Div.), Nagina-Bijnor be laid before Hon'ble Mr. Justice Vivek Varma, Administrative Judge, Bijnor Judgeship for His Lordship's kind perusal and orders?
