In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), his total income is Rs.66,03,934/-(Rs.53,11,552 from salary, Rs.4,65,000 from agriculture, Rs.7,24,882/- from LLM arrear and Rs.1,02,500/- from LIC) and total deductions/repayment/savings/investment against GPF, GIS, Income Tax, PPF, LIC policy, SIP, Loan and Tution Fee is Rs.39,12,943/- and the balance of his savings bank account(s) is also increased by Rs.1,26,219/- this financial year from previous year's balance, total of which is Rs.40,39,162/-. Thus, a sum of Rs.25,64,772/- was available with him to meet out the household expenditure of his family consisting of five members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2018-20 (2018-19 & 2019-20) online against Case id- P00007832020 (Old Case Id: 1629) and same has been processed before the Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Kushinagar at Padrauna Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-22 (2020-21 & 2021-22) vide online dated 17.08.2022. As such, there is no delay in submitting the same.
