May kindly see the property statement online received from Sri. Akhilesh Dubey, Principal Judge, Family Court, Hathras regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22(2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22(2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22(2020-21 & 2021-22), Total income is Rs.57,44,295/- (Gross income from salary including EL Encashment is Rs.55,34,243/- and bank interest Rs.2,10,052/- and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, Home Loan Emi, PPF, Birla Sun Life Fund, SBI Life Insurance Policy's and the balance of his savings bank account(s) is enhanced by Rs.1,84,192/- this financial year from previous year's balance, total of which is Rs.38,13,579/-. Thus, a sum of Rs.19,30,716/- was available with him to meet out the household expenditure of his family consisting of three members in both of the financial years.

It is pertinent to mention here that his Son is working as computer science Engineer having income Rs.18,79,064/- and Rs.22,52,080/- in both the financial years respectively.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2018-20 online against Case Id-P00007072020 and same has been approved by the Hon'ble Mr. Justice Manish Mathur, the then, Administrative Judge, Hathras Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22(2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-22(2020-21 & 2021-22) vide online dated 03.08.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22(2020-21 & 2021-22) of Sri. Akhilesh Dubey, Principal Judge, Family Court, Hathras be laid before Hon'ble Mr. Justice Narendra Kumar Johari, Administrative Judge, Hathras for His Lordship's kind perusal and orders?
