May kindly see the property statement online received from Sri Vinod Kumar-III, District & Sessions Judge, Bareilly regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2020-22 (2020-21 & 2021-22), his gross income from salary and other sources is Rs.58,44,278 (Rs.56,97,057/- from salary, Rs.16,360/- maturity of NSC and Maturity of LIC is Rs.1,30,861/-) and total deductions/Savings/investments against Savings in Bank account, GPF, GIS, Income Tax, GVR, Insurance, FDR and PPF is Rs.28,27,729/-. The balance of Rs.45,703/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.30,16,549/- was therefore available with him to meet out the household expenditure of his family consisting two members in the financial years 2020-22 (2020-21 & 2021-22).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2018-20 (2018-19 & 2019-20) online against e-Service ID 3014, same has been processed before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly Judgship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 30.07.2022. As such, there is no delay submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Vinod Kumar-III, District & Sessions Judge, Bareilly be laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly Judgship for His Lordship's kind perusal and orders?
