May kindly see the property statement online received from Smt. Kamlesh Kuchhal, Districts & Sessions Judge, Banda regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), Total income is Rs.64,02,886/- (Gross income from salary with allowances is Rs.53,13,501/- , Interest from Bank account, FDR, PPF is Rs.10,89,385/- and total deductions/ repayment/ savings/ investment against CPF, GIS, TDS, PPF, SBI Insurance Policy, Bajaj Insurance Policy, One Niva Insurance Policy, FDR and the balance of her savings bank account(s) is enhanced by Rs.11,44,607/- this financial year from previous year's balance, Total of which is Rs.46,96,146/-. Thus, a sum of Rs.17,06,740/- was available with her to meet out the household expenditure of her family consisting of four members in both of the financial years.

It is pertinent to mention here that her husband is working as an Advocate having income Rs.10,01,000/- in both the financial years.

In this connection, it is submitted that the Officer has already submitted her property statements of the 2018-20 online against Case id- P00048492021 and same has been moved before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Banda Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements of the financial years 2020-22 (2020-21 & 2021-22) vide online dated 30.07.22. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Smt. Kamlesh Kuchhal, Districts & Sessions Judge, Banda be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Banda for His Lordship's kind perusal and orders?
