It is pertinent to mention here that her husband is working as an Advocate having income Rs.10,01,000/- in both the financial years.

In this connection, it is submitted that the Officer has already submitted her property statements of the 2018-20 online against Case id- P00048492021 and same has been moved before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Banda Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023.
