In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2020-22 (2020-21 & 2021-22), his gross income from salary is Rs.43,38,187/and total deductions/Savings/investments against Savings in Bank account, GPF, GIS, Income Tax, Insurance and PPF is Rs.26,49,088/-. The balance of Rs.4,83,824/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.16,89,099/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2020-22 (2020-21 & 2021-22).

It is pertinent mention here that officer's wife (Associate Professor, Nehru P.G. College, Chibramau, Kannauj) annual income was Rs.21,54,690/- for the F.Y. 2020-21 and Rs.27,58,647/- for F.Y. 2021-22 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2018-20 (2018-19 & 2019-20) online against case id:P00007862020 (old case id-1632), which already had been seen by Hon'ble Mr. Justice Piyush Agrawal, the then, Administrative Judge, Unnao Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 02.08.2022. As such, there is no delay submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Anand Kumar-I, Additional District & Sessions Judge, Barabanki be laid before Hon'ble Mr. Justice Shree Prakash Singh, Administrative Judge, Barabanki Judgeship for His Lordship's kind perusal and orders?
