May kindly see the property statement online received from Sri Akhil Kumar Nijhawan, Civil Judge (Junior Div.) Pharenda-Maharajganj regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2019-21 (2019-20 & 2020-21), his gross income from salary is Rs.13,67,924/- and total deductions/Savings/investments against NPS, GIS, Income Tax and Repayment of Car Loan are Rs.5,24,832/-. The balance of Rs.55,165/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.8,98,257/- (Rs.8,43,092/- from salary and Rs.55,165/- saving bank account withdrawal) was therefore available himself to meet out the household expenditure for the financial years 2019-21 (2019-20 & 2020-21).

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of Joining in to U.P. Judicial Service online against case id- P00001102021 (old case id-2082) , which had already been seen by Hon'ble Mr. Justice Siddharth, the then Administrative Judge, Bijnor Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide online dated 14.02.2023. As such, there is delay in submitting the same. In this regard officer verbatim; "There was no deliberate delay in filing of property statement on my part. In February 2023,I mistakenly submitted the property statement of year 2020-2022 instead of year 2019-2021.This was a bonafide mistake as i was new to service . I plead ignorance for this mistake of mine. I shall be more vigilant next time & will be submitting property statement regularly on time".

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Akhil Kumar Nijhawan, Civil Judge (JuniorDiv.) Pharenda-Maharajganj be laid before Hon'ble Mr. Justice Shree Prakash Singh, Administrative Judge, Maharajganj Judgeship for His Lordship's kind perusal and orders?
