May kindly see the property statement submitted online dated 06.08.2022 received from Sri Ravi Yadav, Additional District & Sessions Judge, Ramabai Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22(2020-21 & 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-22(2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-22(2020-21 & 2021-22), Total income is Rs.45,00,023/- (Gross income from salary & arrears are Rs.40,99,455/- , agricultural income of Rs.60,000/-, Rs.90,568/- from closed PNB A/c and Rs.2,50,000/- from redeemed mutual fund) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, CPF, Income Tax, NSC, PPF, Insurance policy, Mutual fund and SIP and the balance of his savings bank account(s) is also enhanced for Rs.14,754/- this financial year from previous year's balance are Rs.22,04,355/-. Thus, a sum of Rs.22,95,668/- was therefore available with him to meet out the household expenditure of his family consisting six members in both the financial years. .

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2018-20 which had already been seen by Hon'ble Mr. Justice Rajnish Kumar , the then Administrative Judge, Ramabai Nagar on case id no.1921.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22(2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-22(2020-21 & 2021-22) vide online dated 06.08.2022. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2020-22(2020-21 & 2021-22) of Sri Ravi Yadav, Additional District & Sessions Judge, Ramabai Nagar be laid before Hon'ble Mr. Justice Subhash Vidyarthi, Administrative Judge, Ramabai Nagar Judgeship for His Lordship's kind perusal and orders?
