May kindly see the property statement online received from Sri Satya Nand Upadhyaya, Principal Judge, Family Court, Muzaffar Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2020-22 (2020-21 & 2021-22), Gross income from salary and other sources Rs.54,86,594/-(income from salary is Rs.48,59,486/-, income from LIC Policy Rs.3,85,198/- and withdrawn from PPF a/c Rs.2,41,910/-) and total deductions/savings/ investment against GPF, GIS, GVR, Income Tax, LIC policy and repayment of car & home loan are Rs.26,51,137/-. Thus, a sum of Rs.28,35,457/- was therefore available with him to meet out the household expenditure of his family consisting of four member in the both of the financial year. And the balance of his savings bank account(s) is also decreased by Rs.23,257/- in this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2018-20 online and same has been peocessed before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Muzaffar Nagar on old case Id no-940.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-22 (2020-21 & 2021-22) vide online dated 18.09.2022. As such, there is no delay in submitting the same from part of the officer.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Satya Nand Upadhyaya, Principal Judge, Family Court, Muzaffar Nagar be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Muzaffar Nagar for His Lordship's kind perusal and orders?
