May kindly see the property statement received online from Sri Narendra Nath Tripathi, Addl. District & Sessions Judge, Sitapur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2020-22 (2020-21 & 2021-22), Gross income from salary is Rs.19,86,346/- and total deductions/ savings/ investment against standard deduction, NPS, PPF, shares and mutual funds, and balance of his S.B. A/cs is Rs. 7,15,763/-. Thus a sum of Rs.12,70,583/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years. It is pertinent to mention here that his wife is an Advocate, whose annual income is Rs. 4,17,210/-.

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining into judicial service and the same has been processed online against Case Id : P00016082021 | Old Case Id : 3723 before Hon'ble Mr. Justice Manoj Bajaj, Administrative Judge, Sitapur for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-22 (2020-21 & 2021-22) vide online dated 21.09.2023. As such, there is delay in submitting the same for which he has stated - "due to excessive Judicial work, he could not file the statement with in time and requested to kindly condone the delay in filing this statement."

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Narendra Nath Tripathi, Addl. District & Sessions Judge, Sitapur be laid before Hon'ble Mr. Justice Manoj Bajaj, Administrative Judge, Sitapur for His Lordship's kind perusal and orders?
