And the balance of her savings bank account(s) is reduced by Rs.34,189/- this financial year from previous year's balance.

It is pertinent to mention here that Shri Samay Singh, Father, Annual Income is appx. 2,50,000/- from Pension(Retired Army Personnel) and Sri Yogesh Jain, Husband, Annual Income is appx. 10,80,936/- from salary(working as Civil Judge Jr. Div., Meerut).

In this connection, it is submitted that the Officer has already submitted his property statements of the 2018-20 (2018-19 & 2019-20) online against Case id- P00063462022 and same has been processed before the Hon'ble Mr. Justice Vivek Kumar Birla, Administrative Judge, Meerut.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements of the financial years 2020-22 (2020-21 & 2021-22) vide online dated 13.09.2022. As such, there is no delay in submitting the same.
