May kindly see the online property statements received from Sri Anil Kumar-V, Addl. District & Sessions Judge, Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2014-15 & 2015-16 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2014-15 & 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2014-15 & 2015-16, Total Gross income from salary are Rs.18,91,041/- and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, Home loan, LIC policies, PPF a/c and the balance of his savings bank account(s) is enhanced for Rs.1,43,842/- this financial year from previous year's balance, total of which is Rs.11,44,854/-. Thus, a sum of Rs.7,46,187/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year.

It is pertinent to mention here that his wife earns Rs.3 Lacs and Rs.3,51,600/- per annum from Business in the financial years 2014-15 & 2015-16 respectively.

In this connection, it is submitted that he has already submitted his property statement upto the financial year 2009-10, which has already been seen by Hon'ble Mr. Justice Devendra Kumar Arora, the then Administrative Judge, Sitapur. And property statements of the financial years 2010-11 & 2011-12 and 2012-13 & 2013-14, detailed office notes have been submitted on e-Service IDs P00063472022 and P00063502022 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2014-15 & 2015-16 in its next financial year i.e., 2016-17 upto March 2017. He has submitted movable and immovable property statements for the financial years 2014-15 & 2015-16 vide online dated 23.08.2022. As such, there is delay in submitting the same from the part of the officer for which he has stated that "he could not submit the aforesaid statement within time mistakenly and also due to health issues. He has apologised for delay submission of the same and given assurance to submit the further statements within time regularly in future", mentioned in his attachment letter dated 22.08.2022.

May, therefore, if approved, property statements for the financial year 2014-15 & 2015-16 of Sri Anil Kumar-V, Addl. District & Sessions Judge, Varanasi be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders?
