May kindly see the property statement submitted online received from Sri Rakesh Kumar Gautam, Additional District & Sessions Judge (FTC), Mahoba regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2020-22 (2020-21 & 2021-22), his Total income from salary is Rs.52,90,546/- and total deductions/savings/investments against GIS, NPS, TDS and PPF is Rs.18,92,294/- . Thus a sum of Rs.33,98,252/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years and the balance of his Saving bank A/c is reduced for Rs.1,96,261/- this financial year from previous year's balance.

It is pertinent to mention here that his wife is working as an Advocate and earned Rs. 5,21,670/- and 5,52,223/- annually for the financial years 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial year 2018-20 which has been processed before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, the then Administrative Judge, Mahoba.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto 31st March 2023. He has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) firstly vide his application dated 24.08.2022. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Rakesh Kumar Gautam, Additional District & Sessions Judge (FTC), Mahoba, be laid before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Mahoba for His Lordship's kind perusal and order?
