May kindly see the property statement online received from Sri Gajendra, Spl. Sec.& Addl. LR (NyayVibhag) Government of U.P. Lucknow regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial years 2020-22 (2020-21 & 2021-22)**, his gross income from salary and other sources are Rs.47,19,052/- (Rs.43,57,759/- from salary, Rs.45,346/- maturity of Infrastructure bond and Rs.3,15,947/- from maturity of Insurance policy) and total deductions/Savings/investments against, CPF, GIS, Income Tax, Insurances, Mutual Funds, Sukanya Samriddhi Yojna and Atal Pension Yojna are Rs.32,61,187/-. The balance of Rs.7,19,129/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.14,57,865/- was therefore available with him to meet out the household expenditure of his family consisting six members in the financial years 2020-22 (2020-21 & 2021-22). It is pertinent to mention here that his mother has annual income of Rs. 70,000/- approx. from agriculture.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2018-20 (2018-19 & 2019-20) online against case id-P00006442020 (old case id-1425), which had already been seen by Hon'ble Mr. Justice Vipin Chandra Dixit, the then Administrative Judge, Kasganj Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 29.10.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Gajendra, Spl. Sec.& Addl. LR (NyayVibhag) Government of U.P. Lucknow be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
