May kindly see the property statement online received from Sri Sunil Kumar Verma, Additional District & Sessions Judge, Lakhimpur Kheri regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), his gross income from salary and other sources is Rs. 55,09,527/- (Rs. 45,87,713/- from salary, RS.12,000/-from Electricity reimbursement, Rs. 2,00,000/- from Agriculture, Rs. 80,999/- from saving account interest, Rs. 14,590/- from IT returns, Rs.3,51,400 from maturity of LIC and Rs. 2,74,825/- from maturity of Birla Sun LIfe) and total deductions/Savings /investments against GPF, GIS, Income Tax, Loan-repayment, PPF, FD and Insurances is Rs.39,39,166/- (including enhancement of balance of Rs. 38,240/- in his saving bank A/c against the balance of the previous year). Thus a sum of Rs. 15,70,360/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial years 2020-22 (2020-21 & 2021-22).

In this connection, it is submitted that the Officer has already submitted his property statement of financial years 2018-20 (2018-19 & 2019-20) online against case id-P00003872020(old case id-1080), which has already been seen by Hon'ble Mr. Justice Alok Singh, the then Administrative Judge, Bareilly.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-22 (2020-21 & 2021-22) vide online dated 04.11.2022. As such, there is no delay in submission of property statement.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Sunil Kumar Verma, Additional District & Sessions Judge, Lakhimpur Kheri be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri for His Lordship's kind perusal and orders?
