May kindly see the property statement online received from Sri Abhai Srivastav, Special Judge (E.C. Act), Bareilly regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial years 2020-22 (2020-21 & 2021-22)**, Total income is Rs.58,83,774/- (Gross income from salary is Rs.46,63,740/- and from other sources(bank interest, S.B. A/c closer,PPF account closer and IDFC folio closer is Rs.12,20,034/-) and total deductions/ repayment/ savings/ investment against GIS, CPF,Income Tax, LIC policy's,Mutual fund's,PPF and the balance of his savings bank account(s) is enhanced by Rs.1,47,957/- this financial year from previous year's balance, total of which is Rs.26,82,625/-. Thus, a sum of Rs.32,01,149/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2018-20 (2018-19 & 2019-20) online and same has been approved by the Hon'ble Mr. Justice Siddhartha Varma, the then, Administrative Judge, Sultanpur Judgeship on Case Id : P00004542020 (Old Case Id : 1169).

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-22 (2020-21 & 2021-22) vide online dated 01.09.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Abhai Srivastav, Special Judge (E.C. Act), Bareilly, be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
