May kindly see the property statement online received from Sri Ravindra Kumar-II, Presiding Officer, Motor Accident Claims Tribunal, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-21 & 2021-22 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-21 & 2021-22, Total income is Rs.43,17,441/- (total Gross salary is Rs.37,89,696/- and Income from investments of Rs.5,27,745/-) and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, LIC, PPF, SIP and Liquid Fund are Rs.44,37,664/-. And the balance of his savings bank account(s) is also reduced for Rs.6,80,524/- this financial year from previous year's balance. Thus, a sum of Rs.5,60,301/- was therefore available with him to meet out the household expenditure of his family consisting four members in both of the financial years.

It is pertinent to mention here that his wife is posted as Joint Director prosecution, CBCID, Lucknow having annual income of Rs.13,60,528/- and Rs.15,63,394/- in the financial years 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice Rajnish Kumar, the then Administrative Judge, Hardoi and statements of 2018-20 be online laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow for His Lordship's kind perusal & order, on e-Service ID 2294.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-21 & 2021-22 vide online dated 12.01.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-21 & 2021-22 of Sri Ravindra Kumar-II, Presiding Officer, Motor Accident Claims Tribunal, Lucknow be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow for His Lordship's kind perusal and orders?
