In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income is Rs.60,64,631/-(Rs.53,87,250/- from salary, arrears and allowances, Rs.1,73,507/- from SB interest, Rs.1,49,940/- from House rent & Rs.3,53,934/- from SIP redemption and matured Bonds) and total deductions/savings/investment against GIS, GPF, PPF, SIP, Insurances, Housing loan repayments and Income Tax is Rs.24,84,992/- and the balance of his savings bank account(s) is also increased by Rs.15,86,422/- in this financial year from previous year's balance, total of which is Rs.40,71,414/-. Thus, a sum of Rs.19,93,217/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2020-2022 (2020-21 & 2021-22).

It is pertinent to mention here that his son have annual income about Rs.10,00,000/- from self employment (as mentioned by officer).

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 06.02.2023. As such, there is no delay in submitting the same.
