May kindly see the property statements online received from Sri Ahasan Husain, Additional District & Sessions Judge, Shahjahanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.51,90,760/- (Gross salary is Rs.45,25,101/-, PPF withdrawal of Rs.1,00,000/-, SIP redemption of Rs.1,00,000/-, SBI smart scholar Policy redemption of Rs.3,21,289/-, Transfer T.A. of Rs.61,944/- and fuel imbursement of Rs.82,426/-) and total deductions/repayment/ savings/ investment against GPF, GIS, Income Tax, Home loan, Insurance policies, SIPs, PPF and PLI are Rs.29,06,659/-. Thus, a sum of Rs.22,84,101/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.1,22,758/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice Ramesh Sinha, the then Administrative Judge, Saharanpur in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 firstly vide online dated 23.12.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Ahasan Husain, Additional District & Sessions Judge, Shahjahanpur be laid before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Shahjahanpur for His Lordship's kind perusal and orders?
