May kindly see the online property statements received from Sri Bhupendra Rai, Law Officer, Uttar Pradesh Power Corporation Limited, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2020-22(2020-21 and 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-22(2020-21 and 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-22(2020-21 and 2021-22), Total income from Gross salary is Rs.46,01,840/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, GPF, Income Tax, PPF a/c, Insurance policies, PLI, SIP, NPS and the balance of his savings bank account(s) has been enhanced for Rs.1,65,830/- this financial year from previous year's balance, total of which is Rs.32,95,509/-. Thus, a sum of Rs.13,06,331/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that his wife earns Rs.8,000/- per month from tuition & income about Rs.1,50,000/- per year from Agriculture in the financial year 2020-21 and Rs.9,000/- per month from tuition & income about Rs.1,60,000/- per year from Agriculture in the financial year 2021-22. His son is posted as Analyst in KPMG India Services LLP, Mumbai having monthly income of Rs.70,000/-.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2018-20 which has already been seen by Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then Administrative Judge, Lucknow in the e-Service ID no.P00009612020.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-21 and 2021-22 in its next financial year i.e., 2022-23 upto March,2023. He has submitted movable and immovable property statements for the aforesaid financial years vide online dated 16.06.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 and 2021-22) of Sri Bhupendra Rai, Law Officer, Uttar Pradesh Power Corporation Limited, Lucknow be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow for Her Lordship's kind perusal and orders?
