May kindly see the property statement submitted online received from Smt. Pratibha presently posted as Civil Judge (Senior Div.), Shamli at Kairana regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year 2020-22 (2020-21 & 2021-22), her total income is Rs. 31,18,929 (from salary Rs. 28,06,900 and credit from STDR Rs. 3,12,029) and total deductions/savings/investments against NPS, GIS, Income Tax, PPF, LIC and the balance of her Saving bank A/c(s) is enhanced for Rs.5,35,251/- this financial year from previous year's balance, total of which is Rs. 13,07,749/-. Thus a sum of Rs.18,11,180/- was therefore available with her to meet out the household expenditure of her family consisting of four members in both the financial years.

It is pertinent to mention here that her husband Shri Deepak Siwach is Working in HCL Technologies, Noida at annual Salary Package of Rs. 13.65 Lacs and Rs.14.85 Lacs in the financial years 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the officer has already submitted her property statements upto the financial year 2018-20 and the same has also been approved by Hon'ble Mr. Justice Narendra Kumar Johari, the then Administrative Judge, Hathras online against Case Id : P00009552020 (Old Case Id : 1847).

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statements for the financial year 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) online vide her application dated 25.09.2023. As such, there is delay in submitting the same from the part of the officer for which she has submitted that "due to workload, untimely transfer in December 2022 & bonafide mistake, she could not submit property statements on time. There was no malafide intention. She has requested to accept unconditional apology for delay and to condone the delay" as mentioned by the officer in her attachment letter.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Smt. Pratibha, Civil Judge (Senior Div.), Shamli at Kairana, be laid before Hon'ble Mr. Justice Mohd. Azhar Husain Idrisi, Administrative Judge, Shamli for His Lordship's kind perusal and orders?
