May kindly see the property statement submitted online dated 10.10.2022 received from Sri Surender Kumar, presently posted as Additional District & Sessions Judge, Shamli at Kairana regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2019-21 (2019-20 & 2020-21), Total gross income is Rs.47,81,929/- (income from salary is Rs.46,46,230/- and income from maturity amount of RD a/c is Rs.1,35,699/-)and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Insurance policy, Sukanya Samridhi Yojna, FD and the balance of his savings bank account(s) is enhanced for Rs.97,346/- in this financial year from previous year's balance, total of which is Rs.17,24,027/-. Thus, a sum of Rs.30,57,902/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that his wife Smt. Sonia is excise & taxation Officer, govt. of Haryana, annual income is Rs. 7.9 lac approx.

In this connection, it is submitted that the officer has already submitted his property statements upto the financial year 2017-19 which has been processed online by Hon'ble Mr. Justice Mohd. Azhar Husain Idrisi, Administrative Judge, Shamli on old case ID no.-2188.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) vide online dated 10.10.2022. As such, there is delay in submitting the same from the part of the officer. For which, he stated that he remained on deputation in Central Administrative Tribunal and also due to Covid-19 situations he could not file his property statement within the expected time for that he tenders unconditional apology and also undertake that in future he will file his property statement on time.

May, therefore, if approved, property statements of the financial year 2019-21 (2019-20 & 2020-21) of Sri Surender Kumar, Additional District & Sessions Judge, Shamli at Kairana be laid before Hon'ble Mr. Justice Mohd. Azhar Husain Idrisi, Administrative Judge, Shamli Judgship for His Lordship's kind perusal and orders?
