In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-22 (2020-21 & 2021-22), Gross income from salary is Rs.56,14,003/- and total deductions/ repayment/ savings/ investment against GPF, PPF, GIS, LIC policies, NPS, Home loan EMI, Income Tax and Mediclaim Premium are Rs.32,16,722/-. Thus, a sum of Rs.23,97,281/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.3,98,158/- this financial year from previous year's balance.

It is pertinent to mention here that Officer (an advocate) having annual income Rs.7,46,460/- and Rs.7,65,680/- respectively for the financial years 2020-21 & 2021-22.

In this connection, it is submitted that officer has already submitted his property statement for the financial years 2018-20(2018-19 & 2019-20) against online case id- P00001672021 (old case id-2147), which has been seen by Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 18.10.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Anil Kumar Singh-I, Secretary, Lok Ayukta, Lucknow be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
