May kindly see the property statement submitted online received from Sri Khaliqzama, Additional District & Sessions Judge, Sonbhadra regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-22 (2020-21 & 2021-22), Total income is Rs.48,74,091/- [(Gross income from salary & arrears (including maturity of S.B.I. Child plan of Rs.3,16,166/-, interest from S.B.I saving account of Rs.12,934/-)] and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, GPF, Income Tax, Insurance policies, PPF, and repayment of home loan is Rs.32,47,341/-.. Thus, a sum of Rs.19,98,069/-(Rs.16,26,750/- from salary and Rs.3,71,319/- from saving bank account) was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial year and the balance of his savings bank account(s) is decreased for Rs.3,71,319/- this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial years 2018-20 (2018-19 & 2019-20) online against case id- P00001972021(old case id-2184) and same has been processed before Hon'ble Dr. Justice Gautam Chowdhary, Administrative Judge, Sonbhadra for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-22 (2020-21 & 2021-22) vide online dated 14.11.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Khaliqzama, Additional District & Sessions Judge, Sonbhadra be laid before Hon'ble Dr. Justice Gautam Chowdhary, Administrative Judge, Sonbhadra Judgeship for His Lordship's kind perusal and orders?
