May kindly see the online property statements received from Sri Anil Kumar Vashistha, Presiding Officer, Motor Accident Claims Tribunal, Jalaun at Orai regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2020-21 & 2021-22 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-21 & 2021-22, total Gross income from salary (both the financial years) is Rs.51,09,916/- and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, Insurance policies, NPS, maintenance to his divorced wife & children and Mutual Fund are Rs.42,78,173/-. Thus, a sum of Rs.8,31,743/- was therefore available with him to meet out the household expenditure of himself in both the financial years. And the balance of his savings bank account(s) has also been reduced for Rs.2,51,813/- this financial year from previous year's balance.

It is pertinent to mention here that he has received the matured amount of SBILIFE Smart performer of Rs.21,32,588/- and agricultural income of Rs.2,00,000/-.

In this connection it is submitted that the officer has already submitted his property statement upto the financial year 2018-20 which had already been seen online by Hon'ble Mr. Justice Om Prakash Tripathi, the then Administrative Judge, Sant Kabir Nagar on eService-ID no.P00006392020.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March,2023. He has submitted movable and immovable property statements of the financial years 2020-21 & 2021-22 vide online dated 27.10.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2020-21 & 2021-22 of Sri Anil Kumar Vashistha, Presiding Officer, Motor Accident Claims Tribunal, Jalaun at Orai be laid before Hon'ble Mr. Justice Dinesh Pathak, Administrative Judge, Jalaun at Orai Judgeship for His Lordship's kind perusal and orders?
