May kindly see the property statement received online from Smt. Rashmi Nanda, Additional Principal Judge, Family Court, Varanasi regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), Gross income is Rs.45,99,058/- and total deductions/savings/investment against GPF, GIS, Income Tax, PPF, LIC and the balance of her bank account(s) is also enhanced by Rs.6,06,883/- in this financial year from previous year's balance, total of which is Rs.27,66,881/-. Thus, a sum of Rs.18,32,177/- was therefore available with her to meet out the household expenditure of her family consisting four members in both of the financial years.

It is pertinent to mention here that officer's husband is also working as A.D.J., having annual income of Rs.22,43,636/- & Rs.25,58,206/- for the financial year 2020-21 & 2021-22 respectively, as mentioned by the officer.

In this connection, it is submitted that the Officer has already submitted her property statement upto the the financial year 2018-20 and the same has also been approved online against Case Id : P00004112020 by Hon'ble Mr. Justice Pankaj Naqvi, the then Administrative Judge, Shahjahanpur Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted her movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 28.10.22. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Smt. Rashmi Nanda, Additional Principal Judge, Family Court, Varanasi be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders ?
