May kindly see the property statement received online from Smt. Vijay Raje Sisodia, Special Judge (SC/ST, Pev. of Atroci Act), Baghpat, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income from salary is Rs.43,05,156/- and total deductions/repayments/savings/investments against GIS, GPF, PPF, Insurances, Mutual Funds and Income Tax are Rs.21,32,143/-. Thus, a sum of Rs.21,73,013/- was therefore available with her to meet out the household expenditure of her family consisting four members in the financial year 2020-2022 (2020-21 & 2021-22) and the balance of her savings bank account is also decreased by Rs.73,458/- in this financial year from previous year's balance.

It is pertinent to mention here that her husband is a Judicial Officer having annual income of Rs.13,76,228/- & Rs.14,61,474/- for the financial year 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20), online against Case Id : P0005452020 (Old Case Id : 1293) and the same has been seen by Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then Administrative Judge, Kanpur Nagar Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 05.11.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Smt. Vijay Raje Sisodia, Special Judge (SC/ST, Pev. of Atroci Act), Baghpat, be laid before Hon'ble Mr. Justice Anish Kumar Gupta, Administrative Judge, Baghpat Judgeship for His Lordship's kind perusal and orders?
