May kindly see the property statement online received from Sri Sudeep Kumar Jaiswal, H.J.S., Secretary, Uttar Pradesh State Legal Services Authority, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2010-12 (2010-11 & 2011-12) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2010-12 (2010-11 & 2011-12) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2010-12 (2010-11 & 2011-12), Gross income from salary is Rs.21,80,677/- and total deductions/savings/ investment against GPF, GIS, PPF, Income Tax, Repayment of Home loan and Insurances is Rs.16,99,120/-. The balance of his savings account is also decreased for Rs.1,17,283/- this financial year from the previous year's balance. Thus a sum of Rs.5,98,840/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial years 2010-12 (2010-11 & 2011-12).

It is pertinent to mention here that's Officer mother(family pensioner) has annual income Rs.3,50,000/- (approximately).

In this connection, it is submitted that the Officer has already submitted his property statement up to the financial year 2009-10 on Misc. file of the officer and same has been processed/submitted in offline mode before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2010-12 (2010-11 & 2011-12) in its next financial year i.e., 2012-13 upto March 2013. He has submitted movable and immovable property statements of the financial year 2010-12 (2010-11 & 2011-12) vide online dated 02.11.2022. As such, there is a delay in submitting the same. In this regard, the officer stated that he had been living with his old-aged widowed mother who had been suffering from various ailments. It is also pertinent to mention that both of his brothers-in-law and sister-in-law are settled in abroad . He and his wife had to take care of his parent-in-law got a very rare kind of disease called "Myositis' which caused her muscles to become weak, tired and painful. The nature of disease needed continuous care and regular check-ups in Sanjay Gandhi Post Graduate Institute of Medical Sciences (SGPGIMS), Lucknow till her death in the year 2021, she got treatment at SGPGIMS, Lucknow. Since he had been continuously involved in the process of the treatment and care of his mother and mother-in-law, he could not be able to send his property statement to the Hon'ble Court. Though the delay occurred because of the above circumstances and was not intentional, he tender his unconditional apology to the Hon'ble Court. This explanation is being submitted for kind and sympathetic consideration of the Hon'ble Court.

May, therefore, if approved, property statements for the financial years 2010-12 (2010-11 & 2011-12) of Sri Sudeep Kumar Jaiswal, H.J.S., Secretary, Uttar Pradesh State Legal Services Authority, Lucknow be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow for His Lordship's kind perusal and orders?
