May kindly see the property statement online received from Sri Sudeep Kumar Jaiswal, H.J.S., Secretary, Uttar Pradesh State Legal Services Authority, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2020-22 (2020-21 & 2021-22), Gross income from salary is Rs.54,36,610/- and total deductions/savings/ investment against GPF, GIS, PPF, Income Tax, Insurances and the balance of his savings bank account(s) is also enhanced by Rs.3,21,606/- in this financial year from previous year's balance, total of which is Rs.28,96,256/-. Thus a sum of Rs.25,40,354/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial years 2020-22 (2020-21 & 2021-22).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2018-20 (2018-19 & 2019-20) online against case id- P00064682022 and the same has been processed/ submitted before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 up to March 2023. He has submitted movable and immovable property statements of the financial year 2020-22 (2020-21 & 2021-22) vide online dated 02.11.2022. As such, there is no delay in the submission of the property statement.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Sudeep Kumar Jaiswal, H.J.S., Secretary, Uttar Pradesh State Legal Services Authority, Lucknow be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow for His Lordship's kind perusal and orders?
