In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2019-21 (2019-20 & 2020-21), Total Gross income from salary is Rs.32,53,662/- and total deductions/ repayment/ savings/ investment against GIS, CPF, Income Tax, PPF, Insurance policies and Sukanya Samriddhi Yojna are Rs.14,35,338/-. Thus, a sum of Rs.18,18,324/- was therefore available with her to meet out the household expenditure of her family consisting four members in both of the financial years. And the balance of her savings bank account(s) has also been reduced for Rs.41,962/- this financial year from previous year's balance.

It is pertinent to mention here that her husband is practising Chartered Accountant having annual income of Rs.13,77,500/- and Rs.13,75,000/- in the financial years 2019-20 & 2020-21 respectively.

In this connection it is submitted that she has already submitted her property statements upto the financial year 2016-17, which has already been seen by Hon'ble Mr. Justice B.Amit Sthalekar, the then Administrative Judge, Varanasi with the warning to be careful in submitting the property statements in time, placed in the misc. file of the officer. For the property statements of the financial years 2017-19, a detailed online note has been laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal & order online on eService ID P00010772021.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide online dated 10.11.2022. As such, there is delay in submitting the property statement of the financial year 2019-21 from the part of the officer.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Smt. Shikha Rani Jaiswal, Additional Principal Judge, Family Court, Kanpur Nagar be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders?
