May kindly see the property statement received online from Sri Ram Net, Special Judge (E.C. Act), Rae Bareli regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), Total income (from salary Rs.39,77,965/- & from withdrawal of LIC policy, FD, PPF Rs. 48,44,387/-) is Rs.88,22,352/- and total deductions/savings/investment against NPS, GIS, Income Tax, Home loan and for purchase of plot, is Rs.49,44,061/-. Thus, a sum of Rs.38,78,291/- was therefore available with him to meet out the household expenditure of his family consisting of five members in both of the financial years. And the balance of his savings bank account is also reduced by Rs.31,896/- in this financial year from previous year's balance. It is pertinent to mention here that his father's annual income from farming is Rs.2,00,000/- & 2,50,000/- (approx), in the financial year 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the Officer has submitted his property statement upto the the financial year 2018-20 and the same also has been processed online against Case Id : P00008252020 before Hon'ble Mr. Justice Arvind Singh Sangwan, Administrative Judge, Rae Bareli Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted his movable and immovable property statement for the financial years 2020-22 (2020-21 & 2021-22) firstly vide online dated 16.11.22. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Ram Net, Special Judge (E.C. Act), Rae Bareli be laid before Hon'ble Mr. Justice Arvind Singh Sangwan, Administrative Judge, Rae Bareli Judgeship for His Lordship's kind perusal and orders?
