In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income is Rs.46,19,811/-(Rs.45,82,096/- from salary and Rs.37,715/- from SB interest) and total deductions/savings/investment against GIS, GPF, PPF, Income Tax and House and Car loan repayments including downpayment of Car are Rs.30,68,971/- and the balance of his savings bank account(s) is also decreased by Rs.4,96,235/- in this financial year from previous year's balance. Thus, a sum of Rs.20,47,075/- (Rs.15,50,840/- from salary and Rs.4,96,235/- from SB account)was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2020-2022 (2020-21 & 2021-22).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id: P00008902020 (Old Case Id: 1767) and the same has been seen by Hon'ble Mr. Justice Rahul Chaturvedi, the then Administrative Judge, Pratapgarh Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 17.03.2023. As such, there is no delay in submitting the same.
