May kindly see the property statement online received from Sri Radhey Mohan Srivastava, Spl. Sec. & Addl. l.R.(Legal Cell) Advocate General Office, Prayagraj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2020-22 (2020-21 & 2021-22), his gross income from salary and other sources is Rs.57,93,556/- (Rs.45,95,241/- from salary and arrears, Rs.55,843/- from maturity of LIC, Rs.2,85,000/- from saving bank account interest and Rs.8,29,472/- from maturity of F.D.R.) and total deductions/Savings/investments against Savings in Bank account, NPS, GIS, Income Tax, Repayment of home loan, car down-payment & EMI, Sukanya Samriddhi Yojna, PPF and Insurances is Rs.38,39,472/-. The balance of Rs.9,28,849/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.28,82,933/- (Rs.19,54,084/- from salary and Rs.9,28,849/- from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting five members in the financial years 2020-22 (2020-21 & 2021-22).

It is pertinent to mention here that officer's mother is a pensioner whose annual income was Rs.1,40,000/- for the F.Y. 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2018-20 (2018-19 & 2019-20) online against case id-P00007272020 (old case id-1548), which has already been seen by Hon'ble Mr. Justice Vivek Chaudhary, the then ,Administrative Judge, Gonda Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22), in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-22 (2020-21 & 2021-22) vide online dated 01.12.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Radhey Mohan Srivastava, Spl. Sec. & Addl. I.R.(Legal Cell) Advocate General Office, Prayagraj, be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Allahabad Judgeship for His Lordship's kind perusal and orders?
