May kindly see the property statement online received from Smt. Vidushi Meha, Additional Civil Judge (Senior Div.), Saharanpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2020-22 (2020-21 and 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 and 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2020-22 (2020-21 and 2021-22), her gross income from salary is Rs.26,96,573/- and total deductions/Savings/investments NPS, GIS, Income Tax, PPF, NSC, Home loan stamp duty, Repayment of home loan, Sukanya Samriddhi Yojna and Insurances are Rs.22,42,234/-. The balance of Rs.86,267/- has decreased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.5,40,606/- (Rs.4,54,339/- from salary and Rs.86,267/- from saving bank account withdrawal) was therefore available with her to meet out the household expenditure of her family consisting four members in the financial years 2020-22 (2020-21 and 2021-22).

It is to pertinent mention here that officer's husband (Chief Judicial Magistrate, Chitrakoot) having annual income was Rs.17,80,428/- for the financial year 2020-21 and Rs.20,64,677/- for the financial year 2021-22 respectively.

In this connection, it is submitted that the Officer has already submitted property statement for the financial years 2018-20 (2018-19 & 2019-20) online against case id-P00009542021 (old case id-3037) and same has been processed before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Saharanpur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2020-22 (2020-21 and 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She had submitted movable and immovable property statements for the financial years 2020-22 (2020-21 and 2021-22) vide online dated 01.12.2022 on eServicesJo portal. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 and 2021-22) of Smt. Vidushi Meha, Additional Civil Judge (Senior Div.), Saharanpur be laid before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Saharanpur Judgeship for His Lordship's kind perusal and orders?
